1. Secretary

4. Treasurer

- a. Conference bursary feedback – New guidelines will be made for conference bursary procedure. These include:
- i. The addition of travel, accommodation and membership dues to reimbursements
  - ii. Up to 50% of submitted conference expenses may be reimbursed, up to a maximum amount of \$250 per student per year
  - iii. This should help make bursaries more accessible to students in the arts programs, whose conference expenses may differ from those of science students.
- b. Student Ancillary Fees (SAF) Subcommittee –
- i. Possibility of losing Health Services for summer months.
  - ii. Some fields that we originally thought were ancillary fees are actually operating costs. They include the skills centre and disability services.

5. Communications

6. Senator
