**Equity Commissioner Update (Adam):**

- PACHREA Update
  - o meeting today
  - o revisions to Blackboard system – does not meet standards according to ADOA
    - going to be workshops for how to use it and make it accessible
  - o harassment and discrimination policy and procedures have not been updated since 1995
    - no institutional set-up for students to file a complaint
    - hopefully there will be a draft up in a few months
    - Adam will find out if there is going to be a review process
  - o Academic Advisory Committee held successful anti-oppression training
- Future events planning

- PACHREA planning to do a postcard campaign – anonymous postcards published
- Motion to carry out our own postcard campaign amongst graduate students – as a way to research – TAs and RAs
  - *Motion carried*
- Motion to pursue a cooperation with Active Minds to plan our own events for National Stress-Out Day, Eating Disorder Awareness Week
  - DISCUSSION: Do our own relaxing event for stress-out day, Seasoned Spoon workshop, use addiction as a topic
    - *Motion carried*

### **VP Operations Update (Stephanie):**

- Elections Update
  - Motion to set dates for online election:
    - DISCUSSION: People have already had their chance to campaign; not a concern.
    - Motion amended: election will be held over a week, from this Wednesday to next Wednesday. A reminder email to go out both Tuesdays.
      - *Motion carried unanimously*

### **Senator Update (Kyle):**

- GSC meetings update:
  - Tri-council Scholarships (CIHR; SSHRC; NSERC) expected to be downloaded to universities like OGS (no timeline set) – not a matter of if, but when
    - Limits to how many times you can apply
    - Not sure if faculty scholarships will have same limits
  - GSC would like to have conversation with us GSA about attendance at PD meetings
  - Higher Education Quality Council of Ontario HEQCO reviewing strategic mandate
    - One member would like universities to be more hierarchical – like in States
    - Kaiti: HECQO full of dirty industrialists
  - Programs may appoint a committee member from outside Trent
  - Ottawa U court case where student sued university for inadequate supervision
    - GSC worried about precedent set

### **VP Student Affairs Update (Kim):**

- Bowling debrief
  - 14 participants
  - we only spent \$50 (underbudget!)
  - site very accommodating, gave a free game, ordered pizza, gave us a deal on shoes

- Festivus update
  - Will hold it at McThirsty's
  - Motion: host Festivus on December 7<sup>th</sup>
    - DISCUSSION: Posters would have to be done by Friday, food donation gets people free drink.
    - *Motion carried.*

**Other Business:**

- Beth
  - Please look over your position descriptions for the retreat
  - Planning to put together a Traill FAQ
    - Wants to discuss Traill/Scott House weekend access
- Kaiti
  - Motion to end office hours as of December 6<sup>th</sup> for the semester
    - *Motion carried unanimously*
  - Retreat will happen 10am to 6pm
    - Informal but constructive day
    - If we call it a special meeting we can make motions but that is not the purpose of the day
- Liz
  - PAC for Traill meeting with College Advisory Committee
    - Thinking of reforming college system
    - Traill isn't getting much money
    - Changing to be a college system fee so that Traill gets an equal share of funding
    - Opening it up so people can change their college throughout their university career
    - Each college is going to focus in on one aspect (i.e. sustainability, independent learning)
    - Grad students will not all be assigned to Traill
    - Liz said she would prefer for grad students to all be one college
      - But they didn't care
    - Kyle: Traill does not have a designated senator; all other senators are on behalf of colleges; in the new format; what happens to grad representative; does the GSA position get dissolved?
    - Not decisive; getting feedback
    - Probably going to open up Traill to undergrads again
    - They are asking for consultation; go to the meetings!
    - BETH: Motion to consult with Melanie, who is chair of College Committee, to draft an open letter outlining where we foresee grads fitting in
      - DISCUSSION? Sub-committee with Beth and Liz spearheading would take charge of issue.
      - *Motion carried*
