#### **Sandra (President):**

February was heavily oriented towards the organization of the AGM and the elections. I helped organize the AGM, put up the elections survey and oversaw the emails sent, reminder emails, and final election results report. I also attended the Canadian Graduate Studies (CAGS) conference for a week and gained interesting insights, particularly with regards to skills & career development and equity, diversity, and inclusion in academia. I also met with Craig Brunetti, the Dean of Graduate Studies, and Michael Eamon, Principal of Trill College.

#### **Sebastian (VP Internal Affairs):**

It has been a fairly quiet month. I was involved in planning for the AGM held on February 9th and successfully ran for President of the TGSA! We managed to get the amendments to the By-Laws and Policies ratified by the membership by 82% out of a possible 74 votes, which I think we should be quite proud of.

There are some possible future amendments to be made regarding quorum to ensure that future AGMs run more smoothly, or at least that they can start more easily.

On top of setting up the LAT event, I spoke with Julianna, who would like to open up more opportunities for grad students at Careers. We discussed this at our last meeting and will push for grad studies to get more involved in this process so that grads can find work after completing their degrees. I plan on initiating a meeting in the coming weeks.

We have been approved to do trivia with Traill from Michael Eamon and Jessica Becking. Adrian, who runs the trivia, has yet to respond to me. Also, Jessica Becking no longer works at Traill, so the future of the TGSA and Traill trivia event is not known. I have sent another follow-up with Michael Eamon carbon copied to ensure Adrian's speedy response.

The Learn from the Grads event from last year has officially been revived. The TCSA is preparing advertisements for undergrads, which will be shared among Durham and Trent campus students. We are using the same messaging from the last event, which will be sent out to grads near the beginning of the coming week (the first week of March). I have contacted last year's interested panellists and have unfortunately heard nothing back. The event will be held on March 25<sup>th</sup> from 1 pm-3 pm.

Tanya, our equity commissioner and I have met to discuss the new equity event. Given my time commitments and the end of term, it is unlikely that an effective poverty discussion can be held. Instead, we have chosen to focus on Representations of Gender on campus, with Tanya contacting individuals on campus we could partner with. If anyone would like to help, please do let us know.

In April, we will still be having our end-of-the-year event. Much like Festivus, I propose this as a social party on Zoom given the lack of knowing the province and Peterborough COVID mandate in April. However, beyond that party, and depending on COVID, I think it would be an excellent idea for the Board to attempt a meet-up for the last event together before a large group of us bid the TGSA a farewell.

Finally, I am excited to welcome our new board members to the table. The newly elected VP of Student Affairs will be invited to attend any of my meetings mentioned above and planning events from here on out to open up a dialogue with individuals I have been working with over my term.

**Janina (VP Senate):**

The VP Senate tasks in February included:

- CASSC meeting: Budget update from housing and food services
  - o As expected, both run a deficit because of COVID
  - o Update student affairs: in-person classes shall resume in the fall term as much as possible, however, contingency plans are in place
- Preparing the AGM report
- Senate exec meeting
- Senate meeting:
  - o Update on Laurentian University
  - o Trent's funds are in order (Leo)
    - No research fund is mixed up with the university's operating budget
    - Trent has suffered financial damage due to COVID, but is financially stable
  - o Lively discussion about the Bachelor of Education's request to establish pass/fail option for first year students. Request approved. Discussion opened for other departments to do the same. Large support from majority of senators.
    - Craig: option not recommended for grad students as it might pose problems to attain post-doc positions
  - o Non-mandatory Camera policy:
    - Senator Henderson sent out guidelines to all of Durham faculty with emphasis on NON-mandatory camera in class
    - Faculty council is working on policy for all of Trent
    - Recommendation from senators Ali Fraser and Rayna: maybe policy not necessary, but send out guidelines and make sure it is an accessibility issue
      - Discussion still ongoing
- Senate Nominating and Governance Subcommittee:
  - o First meeting in two years
  - o Deciding on proposals from TCSA and Trill College to attain additional seats in senate
  - o Next meeting in March; Discussion about "radical changes to allocation of student seats" open
