Executive Reports

Emma (President)

CASSC Updates

- Ancillary fee changes
 - College Fee: increased by 5.5%

Trent Graduate Student Association (TGSA)

- Athletic & Recreation Fee: increased by 5.5%
- Campus Card Fee: increased by 7.9% (\$0.73) to \$10.00
- Campus Safety Fee: increased by 6.9%
- Orientation Fee (graduate students do not pay): increased by 6.9%

Research Policy Committee Meeting

- Adjudication of Distinguished Research Award, Research Impact Award, and Early Career Researcher Awards
 - Celebration of receipts on May 3rd
- Meeting with the ORI about Public Scholar Initiative
 - VP Bruce is interested in teaming up with SGS to create a Public Scholar Initiative at Trent

Board of Governors Meeting

- Operating budgets
 - 2.67% growth expected
 - Includes updates to collective agreements
 - Banking on increasing enrolment to be able to float increased expenses
 - \$388K leftover = balanced budget
 - \$5.2 million in investment for academic and financial supports
 - Conservative budget just in case something happens
 - Inflation
 - Utilities went up 39%
- 83-85% of Trent students come from outside of the regional area
 - The most of any regional university in Ontario

Graduate Studies Committee Meeting

- The 10-hour rule for working on campus doesn't exist anymore!
 - Graduate students can work as many hours on campus as they want, as long as it is not the equivalent of full-time hours
 - No approval from supervisors is needed
 - It is still expected that graduate students work at least 30 hours per week on their research
- There are difficulties cross-listing UG and Grad courses
 - There are UG courses that can be selected as electives for some programs
 - Students are also encouraged to explore equivalent courses at other institutions
- Updates to Graduate Academic Integrity Policy to include information about AI
- Proposal for a Masters in Health Management and Leadership
 - Needs some detail fleshed out before moving forward
- Adjudication process for Mentorship Awards

Sustainability Planning Consultation

- Invited to participate in a consultation about what graduate students would like to see from Trent as far as sustainability goes

Librarian Search Committee

- Conclusion of the librarian search committee with a recommendation put forward to the Provost

ThinkGrad

- Discussed funding for graduate students and how different institutions are moving forward with how to address the need for more funding
