Executive Reports

Sandra (President):

This January was about setting up the new semester. I have been responding and addressing some students' concerns. Lastly, I have attended Student leaders' meetings and the Anti-racism Task Force as usual.

Sebastian (VP Internal Affairs):

Over the past few weeks since the last meeting, I've been involved in a small way with ensuring that the election and AGM planning is going smoothly, though at an arms-length.

Following the Board meeting earlier this month, I updated the By-Laws and forwarded them so that they can be updated on the TGSA website.

I also sent along materials to be distributed on behalf of the Sexual Violence Prevention Educator at Trent, Malika Whelan, to the TGSA grad list.

Over the next week before the February Board meeting, I plan to reach out to both Sandra and Jordon who are overseeing the upcoming elections to ensure that a version of all the previously Board approved amendments to our By-Laws are included in the election material as has been done in previous years.

In January, I attended the monthly CASSC, senate exec, and senate meeting. We approved minor and major changes to various programs brought forward by the Undergraduate and Graduate studies committees. We approved the report of the undergraduate academic Policy committee and of the academic planning and budget committee. The committee presented a draft for a new archive policy that is supposed to regulate the care, acceptance, and management of Physical and digital archival materials at Trent. Lastly the committee presented a new policy concerning research involving human participants. All policy changes can be found in detail in the senate minutes. At cassc, we mostly shared updates about what is going on at the different colleges and at The Trent health and wellness Center. They are currently applying to be eligible to vaccinate students on campus once the covid vaccine will be available. This service will most likely prioritize students in resident. From what I understand, covid testing is already available on campus. They also hired their first BIPoC counselor and are now offering single therapy sessions for students. Both are reactions to the additional demand counseling Has experienced since the beginning of the pandemic. So that's exciting news. And lastly, I am working on filling new open representative positions with TGSA members
