# **Executive Reports**

## **Sandra (President):**

The month of December has been pretty calm since we went on holidays. This included attending the TCSA Board meeting on December 6th, and subsequently helped draft a letter to the TLNAP Planning committee and Trent Vice President External Relations and Advancement, Julie Davies.

On December 18th, I attended a meeting with representatives of the TGSA and CUPE 3908 on the topic of developing a program of awareness and outreach for Sexual Violence Prevention among graduate students with Trent Sexual Violence Prevention Educator, Malika Whelan.
