Sebastian was on the hiring committee for VP Research and Innovation. Kathy Bruce was hired into the role. On Sunday, Sebastian handed out the \$500 award at the 3MT competition. Attended the final student leader meeting of the year and introduced Emma to various college representatives for continuity.

Sebastian met with the Acting Dean of Graduate Studies (James Connolly) with Emma to help with her transition.

Should be further discussion on the allocation of space for students who exceed their funding period.

b.) VP Senate – Devon

Devon is currently focusing on talking to the Peterborough Examiner on nepotism at Trent University.

Concerns about how research is managed across all disciplines. The policy now discusses management on STEM based research. This has been raised to Tri Council to review data management amongst other areas. Who is responsible for data management if the two parties are the graduate student and supervisor? The survey for data management will be made mandatory for faculty who wishes to apply for a Tri-Council grant. The past senate meeting was discussion on new degrees and new programs. The new M.Sc. Anthropology has been approved that won't require extra supervisory capacity. A M.A Anthropology candidate can convert to a M.Sc with the permission of a committee after revision on qualification.

Report from Board of Governors came to the end of Senate meeting that entails that the university has set \$0 for the 2022-2023 academic year. This means that reserves for masks and hand sanitizers will not be replenished. Universities will be scored by department based on student enrollment and funding is allocated based on this. Enrollment metrics between Durham and the Symons campus are separate.

The university is preparing a fiscally normal year starting September 2022. Therefore, the proposal that the acting Dean of Graduate studies, James Connolly is preparing for the Board of Governors will be passed onto to Craig, who may not support this.

Social sciences and humanities fields are under pressure to have their students graduate on time due to lack of funding compared to STEM-related disciplines.

Devon suggests another senate position on the Board, a notice should be sent out as a call for nominations.

c.) Upcoming President – Emma

Met with various contacts with Sebastian to prepare for her position. Emma has as meeting with food services. Her contact Shelly will also attend. Emma will receive a report about how much emission students are emitting. Many students have vocalized the issue with cups at Starbucks. The initial document should be a declaration that any student membership or board can sign and commit to being sustainable at the school, as well as showing that they're committed to climate change. The second report will be the open letter to Trent.

d.) VP Student Affairs – Gabriella

Planned and contacted the Ceilie for arrangements during the day of the event. Care packages for the spring is set for this month for distribution.

e.) Equity Commissioner – Tanya

Tanya has been working with a lady from the Trent Consent group and hopes to connect with the TGSA and wants branch over to graduate students. Tanya will connect the contact to the incoming equity commissioner and president.

f.) Cultural Studies Rep – Richard Moore

Noticed that the 1st year cohort leans towards a larger male presence. Could potentially be a varying number of applications that differ year to year.
