- a.) Emma President
- (i) Resignation of Equity Commissioner and Cultural Studies representative because of personal life reasons
- (ii) Convocation photos
- Lou Fitze of Fitze Photography took free photos of the 2020, 2021, and 2022 graduates on June 8th as they walked across the stage,
- This was very well received by graduating graduates. 68% of the students that did walk across the stage reached out before the ceremony requesting their photos, and additional students that requested their photos after the ceremony brought that number up to 72% of students

- Lots of policy amendments passed (nothing that directly impacts graduate students)
 - o Sexual Violence Policy passed with recommendations to be brought back to the task force: Why is there a section that specifically highlights sexual assault against women and marginalized women?

(vi) Meeting with Dean of Graduate Studies (James Conolly)

- Canadian Studies + Indigenous Studies Masters program is combined
 - This is not liked by many students as Indigenous Studies students do not feel like they have enough representation as many of the classes taught are from the point of view of colonizers

- Representation for graduate students
 - oTrent's \$100 million campaign
 - Julie Davis (VP of Relations) is meeting with the Deans of each department to discuss where the money should go and what it should be used for
 - Will talk with Julie to potentially get some funding to get some graduate space at Symons
- Introduction of a new program: Interdisciplinary Aging Studies
 - oLess science, more social work: 2-year research MA + placement to work in elder care/hospital
 - oLinked to old age centre going in at Trent
- Something interesting:
 - For the first time ever the administration is asking for specifics when it comes to financial projections (ie. enrolment, allocation of resources, program expansion etc.)
 - International acceptances are up 60%

(vii) Meeting with Mark Murdoch (Food Services)

- Publicly issued request for proposal (RFP) for the Bata Bean
 - Charwell's took over the space as local establishments contacted said they did not want to do it
 - White Buffalo Coffee Company out of Calgary is an Indigenous and smudgecertified coffee company that will be selling coffee out of the Bata Bean (we will be buying their coffee from them and selling out as a grab-and-go style)
- Original concept of the Bata Bean was to have local businesses provide their own snacks/pastries/sandwiches etc. to be sold (increases awareness of local businesses and is another source of income for the business)
 - o TGSA can assist with helping this vision come to life in exchange for getting our name on the Bata Bean = marketing for us
 - Tell local businesses that they only need to provide goods and not have to provide staffing

(viii) Meeting with Provost Khan

 - Is Revamping the continuing education fee and is providing a fund for graduate students that go overtime due to extenuating circumstances
 - o Brought up our prior options and opinions on graduate fees for students who have gone overtime
